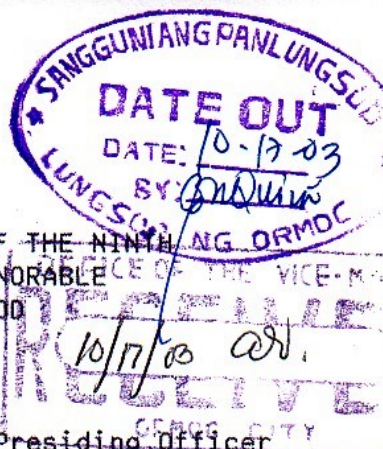


ADOPTED, October 16, 2003.


