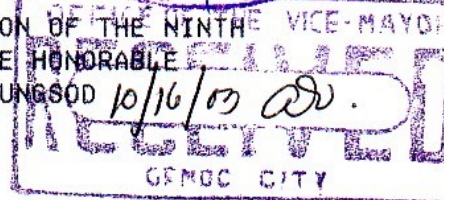

RESOLUTION NO. 2003-187

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE SELF-EMPLOYMENT ASSISTANCE KAUNLARAN (SEA-K) INTEGRATED PROGRAM, AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR FINANCIAL ASSISTANCE TO SEA-KAUNLARAN ASSOCIATION AMOUNTING TO THREE HUNDRED FIFTY THOUSAND PESOS (P350,000.00).

WHEREAS, this august Body is in receipt of 1st Indorsement dated October 10, 2003 from the Honorable City Mayor Carmelo J. Locsin re: Memorandum of Agreement by and between the MILS SEA KABAYAN represented by Lucino Paredes, the Department of Social Welfare and Development represented by Jim Rebutillo and the City Government of Ormoc represented by Honorable City Mayor Carmelo J. Locsin and requesting for the passage of a resolution authorizing him to sign the said Memorandum of Agreement;

WHEREAS, said memorandum of Agreement mentions that the Development of Social Welfare and Development shall grant financial assistance to different SEA-KABAYAN beneficiaries payable within a period of 3 years, following the same policy imposed by the DSWD;

WHEREAS, this august Body has considered said request reasonable and beneficial, hence, the same be accorded the necessary course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Fe S. Lladoc, Chairman, Committee on Social Welfare, duly seconded by City Councilor Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J.
