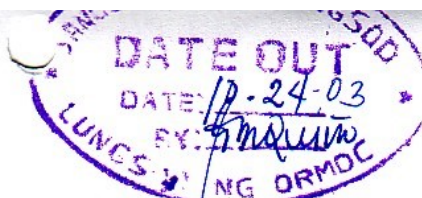
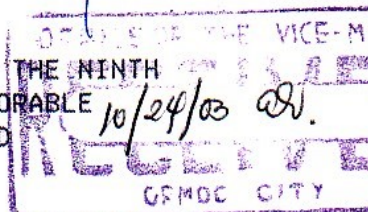

Councilor Fe S. Lladoc; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING

ADOPTED, October 23, 2003.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
