A RESOLUTION APPROVING ORDINANCE NO. 03-01, SERIES OF 2003 OF THE BARANGAY COUNCIL OF BARANGAY IPIL, THIS CITY, ENTITLED: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BRGY. IPIL AS MARINE RESERVE AREA WITH FISH SANCTUARY."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 03-01, Series of 2003 from the Barangay Council of Barangay Ipil, this city, entitled: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BRGY. IPIL AS MARINE RESERVE AREA WITH FISH SANCTUARY";
