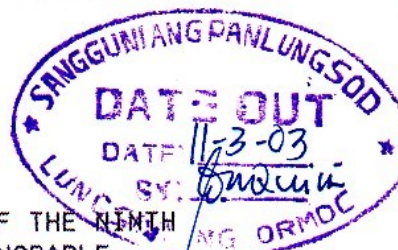
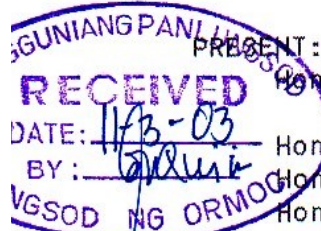

RESOLUTION NO. 2003-193

A RESOLUTION APPROVING ORDINANCE NO. 05, SERIES OF 2003
OF THE BARANGAY COUNCIL OF BARANGAY BANTIGUE, THIS
CITY, ENTITLED: "AN ORDINANCE DECLARING THE COASTAL
WATERS OF BARANGAY BANTIGUE A TOTAL AREA OF 16.6
HECTARES AS MARINE RESERVED AREA AND 4.0 HECTARES AS
THE CORE AREA."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
05, Series of 2003 from the Barangay Council of Barangay Bantigue, this
city, entitled: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BARANGAY
BANTIGUE A TOTAL AREA OF 16.6 HECTARES AS MARINE RESERVED AREA AND 4.0
HECTARES AS THE CORE AREA;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to
Review as to whether the said ordinance is consistent with law and city
