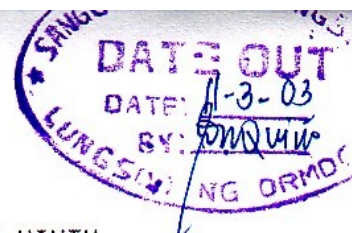

RESOLUTION NO. 2003-194

A RESOLUTION APPROVING ORDINANCE NO. 003, SERIES OF 2003 OF THE BARANGAY COUNCIL OF BARANGAY CAMP DOWNES, THIS CITY, ENTITLED: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BRGY. CAMP DOWNES WITH A TOTAL AREA OF 12 HECTARES; 10 HECTARES AS FISH SANCTUARY AND THE REST IS MARINE RESERVED AREA."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 003, Series of 2003 from the Barangay Council of Barangay Camp Downes, this city, entitled: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BRGY. CAMP DOWNES WITH A TOTAL AREA OF 12 HECTARES; 10 HECTARES AS FISH SANCTUARY AND THE REST IS MARINE RESERVED AREA";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to Review as to whether the said ordinance is consistent with law and city ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Camp Downes to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Fernando P. Parrilla, Chairman, Committee on Fisheries, jointly seconded by City Councilors Fe S. Lladoc & Rafael C. Omega, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING ORDINANCE NO. 003, SERIES OF 2003 OF THE BARANGAY COUNCIL OF BARANGAY CAMP DOWNES, THIS CITY, ENTITLED: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BRGY.
