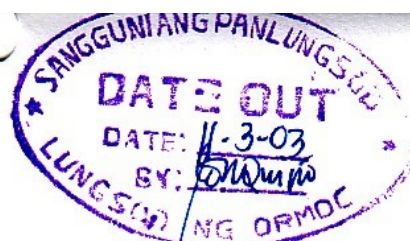

duly seconded by City Councilor Rafael C. Omega, Jr.; be it


