

RESOLUTION NO. 2003-197

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN AND ACCEPT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AS DONEE, A DEED OF DONATION EXECUTED BY THE HEIRS OF ANIANA MAGALLANES AS DONORS OF PARCEL OF LAND FOR ROAD-RIGHT-OF-WAY PURPOSES DESIGNATED AS LOT 7758-B-6 SITUATED IN BARANGAY JUATON, ORMOC CITY WITH AN AREA OF NINE HUNDRED THIRTY THREE (933) SQUARE METERS MORE OR LESS.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 16 September 2003 from the Honorable City Mayor Carmelo J. Locsin, requesting for the passage of a resolution authorizing him to sign and accept donation of a parcel of land for road right of way purposes executed by the heirs of Aniana Magallanes namely, Vicenta Gayo and Dionisio Magallanes as Donors involving Lot 7758-B-6 situated in Barangay Juaton, this city with an area of Nine Hundred Thirty Three (933) square meters more or less;

WHEREAS, the Sangguniang Panlungsod ng Ormoc believes that said donation made by the Donors is of great help to the City Government of Ormoc as well as to the said barangay, having been made with the object of not defrauding their creditors having reserved to themselves, property sufficient to answer their debts contracted prior to said donation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, duly seconded by City Councilor Gregorio A. Yrastorza, Jr.; be it


