

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN TO SIGN AND ACCEPT FOR AND IN BEHALF OF THE
CITY GOVERNMENT OF ORMOC AS DONEE, A DEED OF DONATION
WITH MELCHOR RITA LARRAZABAL ENTERPRISES INC. AS DONOR,
FOR A PARCEL OF LAND LOT 1652-L-2 PART (PORTION OF LOT
1642-L-2 LRC PSD-271038), SITUATED IN BARANGAY
BANTIGUE, ORMOC CITY, WITH AN AREA OF FIFTY SIX (56)
SQUARE METERS MORE OR LESS, COVERED BY TCT NO. TP-472.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 14
October 2003 from the Honorable City Mayor Carmelo J. Locsin requesting
for the passage of a resolution and authorizing him to sign and accept
said Deed of Donation executed by Melchor Rita Larrazabal Ent. Inc. as
Donor in favor of the City Government of Ormoc as Donee, a parcel of
land Lot 1652-L-2 Part (Portion of Lot 1652-L-2 LRC PSD-271038),
situated in Barangay Bantigue, Ormoc City with an area of fifty six (56)
square meters more or less covered by TCT No. TP-472;
