RESOLUTION NO. 2003-200

RESOLUTION GRANTING A MINIMUM OF FREE WATER CONSUMPTION NOT EXCEEDING ONE HUNDRED TWENTY (120) CUBIC METERS PER REGINNING JANUARY 2004 TO THE COGON CENTRAL SCHOOL AND TO WRITE OFF ITS PENDING OBLIGATION WITH CRWASA.

WHERE4S, this Sanggunian is in receipt of Barangay Resolution No. 2003 from Barangay Cogon, this city, entitled: "A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE CARMELO J. LOCSIN TO ALLOW THE OFFICERS OF THE COGON CENTRAL SCHOOL AND ORWASA MANAGEMENT TO WRITE THE SCHOOL'S HUGE WATER ACCOUNT WITH ORWASA FOR THE REASON THAT ORWASA'S PIPES/RESERVOIR AND SIMILAR CONNECTING PIPELINES ARE DRAGGED IN AND THEREBY ENCROACHING BIG PORTION OF THE SCHOOL'S LAND/PROPERTY WITHOUT ANY RENTAL AND TO PERMANENTLY EXEMPT THE SAID SCHOOL FROM PAYING THEIR SUCCEEDING WATER CONSUMPTION";

WHEREAS, said resolution mentions of Cogon Central School's water account with ORWASA in the amount of FIFTEEN THOUSAND PESOS (P15,000.00) which the school would like to write off for the reason that ORWASA'S pipelines are dragged in and thereby encroaching a big portion of the school's property without any rental;

WHEREAS, the school officials as well as the barangay officials of Brgy. Cogon, this city, together with representatives from ORWASA, representative from, the City Treasurer's Office have agreed during a meeting on October 23, 2003 that a grant of a minimum free water consumption not exceeding sixty (60) cubic meters per month to Cogon Central School is reasonable instead of permanently exempting the said school from paying their succeeding water consumption;

WHEREAS, this august Body believes that this situation is somewhat similar to the case of Mr. Sabin Larrazabal wherein the City of Ormoc has granted a minimum of free water consumption of 60 cubic meters per month per SP Resolution No. 822 dated May 20, 1980;

WHEREAS, however, cognizant of the fact that said school is not only catering water to its increasing number of students, but also to some residents of Barangay Cogon, the 9th Sangguniang Panlungsod after thorough deliberation has allowed to grant not to exceed One Hundred Twenty (120) cubic meters of free water consumption to said school instead of sixty (60) cubic meters as requested;

WHEREFORE, foregoing premises considered, on motion of City Councilor Fernando P. Parrilla, City Councilor in Charge, jointly seconded by City Councilors Gregorio A. Yrastorza, Jr. & Rafael C. Omega, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution GRANTING A MINIMUM OF FREE WATER CONSUMPTION NOT EXCEEDING ONE HUNDRED TWENTY (120) CUBIC METERS PER MONTH BEGINNING JANUARY 2004 TO THE COGON CENTRAL SCHOOL AND TO WRITE OFF ITS PENDING OBLIGATION WITH DRWASA;
