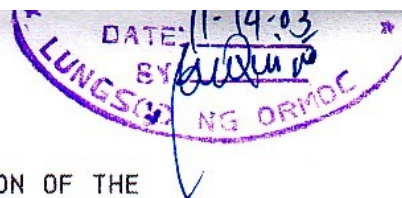

FOR THE HOUSING/COMMUNITY DEVELOPMENT PROJECT AT BARANGAY TAMBULILID, THIS CITY.


