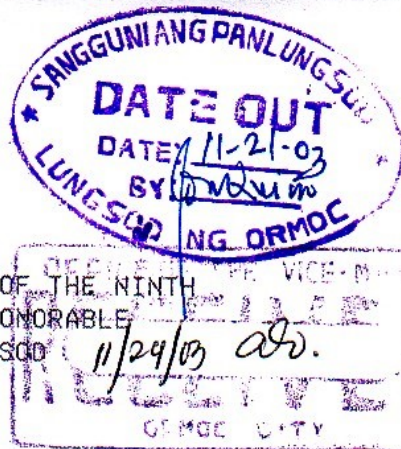

RESOLUTION NO. 2003-206

A RESOLUTION APPROVING ORDINANCE NO. 2003-01 OF THE  
BARANGAY COUNCIL OF BARANGAY DISTRICT 29, THIS CITY,  
ENTITLED: "AN ORDINANCE IMPOSING CURFEW HOURS TO ALL  
PERSONS WITH AGES RANGING FROM EIGHTEEN YEARS OLD BELOW  
FROM 10:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN  
THE MORNING OF THE FOLLOWING DAY, PROVIDING PENALTIES  
AND EXCEPTIONS THEREOF."

WHEREAS, this Sanggunian is in receipt of the Barangay Ordinance  
No. 2003-01 of the Barangay Council of Barangay District 29, this city  
entitled: "AN ORDINANCE IMPOSING CURFEW HOURS TO ALL PERSONS WITH AGES  
RANGING FROM EIGHTEEN YEARS OLD BELOW FROM 10:00 O'CLOCK IN THE EVENING  
TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY, PROVIDING PENALTIES  
AND EXCEPTIONS THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited Ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City) is by law granted the Power to

Fe S. Lladoc; be it


