OF PUBLIC WORKS AND HIGHWAYS, PROHIBITING THE CONSTRUCTION OF ANY STRUCTURE WITHIN THE ROAD-RIGHT-OF-WAY OF THE NATIONAL HIGHWAY WITHIN THE BARANGAY".

MHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2003-001 of the Barangay Council of Barangay Luna, this city, entitled: "AN ORDINANCE ADOPTING AND IMPLEMENTING THE POLICY OF THE DEPT.
