RESOLUTION NO. 2003-207

A RESOLUTION APPROVING ORDINANCE NO. 2003-001 OF THE  
BARANGAY COUNCIL OF BARANGAY LUNA, THIS CITY, ENTITLED:  
"AN ORDINANCE ADOPTING AND IMPLEMENTING THE POLICY OF  
THE DEPT. OF PUBLIC WORKS AND HIGHWAYS, PROHIBITING THE  
CONSTRUCTION OF ANY STRUCTURE WITHIN THE ROAD-RIGHT-OF-  
WAY OF THE NATIONAL HIGHWAY WITHIN THE BARANGAY".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.  
2003-001 of the Barangay Council of Barangay Luna, this city, entitled:  
"AN ORDINANCE ADOPTING AND IMPLEMENTING THE POLICY OF THE DEPT. OF  
PUBLIC WORKS AND HIGHWAYS, PROHIBITING THE CONSTRUCTION OF ANY STRUCTURE  
WITHIN THE ROAD-RIGHT-OF-WAY OF THE NATIONAL HIGHWAY WITHIN THE  
BARANGAY";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City) is by law, granted the Power to  
Review as to whether the said ordinance is consistent with law and city  
x x x ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said  
ordinance has conformed to pertinent provisions of the Local Government  
Code, hence, reasonable and within the province of the Sangguniang  
Barangay of Barangay Luna to legislate;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws &  
Ordinances, duly seconded by City Councilor Jose S. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING ORDINANCE NO. 2003-001 OF THE BARANGAY COUNCIL OF BARANGAY LUNA, THIS CITY, ENTITLED: "AN ORDINANCE ADOPTING AND IMPLEMENTING THE POLICY OF THE DEPT. OF PUBLIC WORKS AND HIGHWAYS, PROHIBITING THE CONSTRUCTION OF ANY STRUCTURE WITHIN THE ROAD-RIGHT-OF-WAY OF THE NATIONAL HIGHWAY WITHIN THE BARANGAY";
