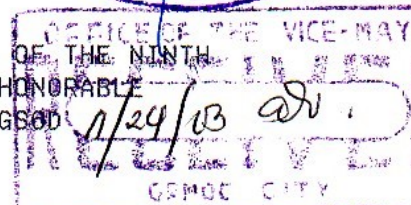


ADOPTED, November 20, 2003.


