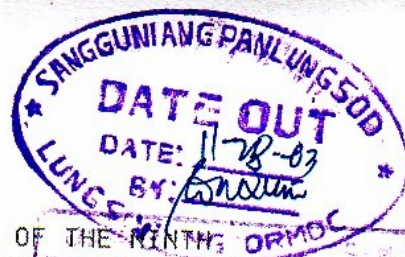

Councilor Gregorio A. Yrastorza, Jr.; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING

ADOPTED, November 27, 2003.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
