A RESOLUTION REQUESTING THE NATIONAL HISTORICAL INSTITUTE FOR THE APPROVAL OF CRISTOBAL S. MENDOLA SIREET IN ORMOC CITY SITING THEREIN THE SIGNIFICANT CONTRIBUTION HIS OF THE LATE CRISTOBAL S. MENDOLA AS CONTAINED IN HIS BIODATA AND PER RECOMMENDATION OF THE CITY PLANNING AND DEVELOPMENT OFFICE, THIS CITY.

WHEREAS, this august Body is in receipt of a letter dated 13 November 2003 from Executive Director Ludovico D. Badoy of the National Historical Institute requesting to be advised on the following:

- 1) The significant contribution made by the late Cristobal Mendola in the locality.
- The said street is not a continuous one and, therefore it 2) might create confusion in the future should it bear just one name.

WHEREAS, the late Cristobal S. Mendola has consistently served the people of Ormoc and earned a name to be a fighter and defender of the lowly and the underprivileged. He was appointed in the city council and later on won the seat in the election to become a member of the First Sangguniang Panlungsod ng Ormoc;

WHEREAS, as regards the second request, quoted hereunder is second paragraph of the 2nd Indorsement dated 09 December 2003 from Engr. Dario D. Sarit, Planning Officer IV, Zoning Administrator, City Planning & Development Office this city which states:

Res. No. 2003-226

"Relative thereto the extension of the existing road of the proposed CRISTOBAL S. MENDOLA STREET (Junction Aunubing Street) is within the vicinity of the New City Hall Building -Zoned as Government Center is RESERVED for other street names by the City Government and therefore cannot be continuous." WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, jointly seconded by City Councilors Eduardo P. Tan & Jovencio A. Laurente; be it
