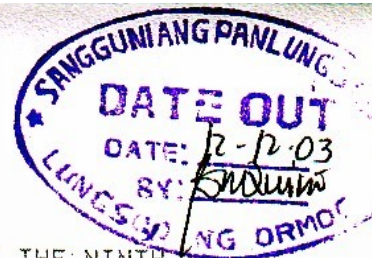

RESOLUTION NO. 2003-228

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE CITY GOVERNMENT OF ORMOC, THE NATIONAL DAIRY AUTHORITY (NDA) AND THE OCCIDENTAL LEYTE DAIRY PRIMARY MULTI-PURPOSE COOPERATIVE (OLDAPRIMCO), FOR THE RENEWAL OF THE COMMUNITY MILK FEEDING PROGRAM.

WHEREAS, this august Body is in receipt of 1st Indorsement dated November 28, 2003 from the Honorable City Mayor Carmelo J. Locsin, requesting for a resolution authorizing him to sign a Memorandum of Agreement by and between the City Government of Ormoc, the National Dairy Authority (NDA) and the Occidental Leyte Dairy Primary Multipurpose Cooperative (OLDAPRIMCO), for the renewal of the Community Milk Feeding Program;

WHEREAS, said MOA which was signed two years ago was for a period of three consecutive years and considering that the second year of said program has just been finished, it has to be renewed for the year 2004;

WHEREAS, the Community Milk Feeding Program is geared to continue the rehabilitation of malnourished children aging 2 - 6 years old preschoolers in the different barangays of Ormoc City;

WHEREAS, this august Body has considered said request reasonable and beneficial, hence, same is accorded due course of action;

WHEREFORE, on motion of City Councilor Fe S. Lladoc, Chairman, Committee on Social Welfare, duly seconded by City Councilor Rafael C. Omega, Jr.; be it
