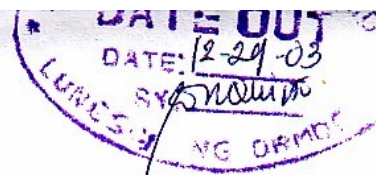

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO  
J. LOCSIN TO ENTER INTO AND SIGN A MEMORANDUM OF  
AGREEMENT BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE-  
EASTERN VISAYAS INTEGRATED AGRICULTURAL RESEARCH  
CENTER, REGIONAL FIELD OFFICE NO. 8 AND THE LOCAL  
GOVERNMENT UNIT OF ORMOC, FOR THE IMPROVEMENT OF THE  
CITY RESEARCH AND EXTENSION CENTERS (CREC) OPERATION.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 8  
December 2003 from the Honorable City Mayor Carmelo J. Locsin,  
requesting for authority to enter into and sign a Memorandum of  
Agreement by and between the Department of Agriculture - Eastern Visayas
