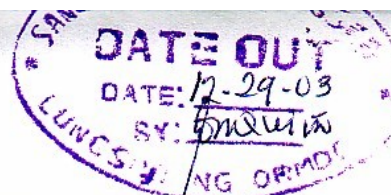

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN TO ENTER INTO AND SIGN A MEMORANDUM OF
AGREEMENT BY AND AMONG THE DEPARTMENT OF AGRICULTURE
REGIONAL FIELD UNIT NO. 8, THE CITY GOVERNMENT OF ORMOC
AND THE ORMOC CITY JACKFRUIT PRODUCERS AND FARMERS
ASSOCIATION, FOR THE IMPLEMENTATION OF THE GININTUANG
MASAGANANG ANI PROGRAM THROUGH ITS PLANT NOW PAY LATER
(PNPL) SCHEME, OF WHICH HIGH VALUE COMMERCIAL CROPS
(HVCC) DEVELOPMENT IS A MAJOR COMPONENT.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 24
November 2003 from the Honorable City Mayor Carmelo J. Locsin,
requesting for authority to enter into and sign a Memorandum of
Agreement by and among the Department of Agriculture Regional Field Unit
No. 8, the City Government of Ormoc and the Ormoc City Jackfruit
Producers and Farmers Association for the implementation of the
Ginintuang Masaganang Ani Program through its Plant Now Pay Later (PNPL)
Scheme, of which high value commercial crops (HVCC) development is a
major component;

WHEREAS, the ultimate objective of the said program is to empower
the private sector particularly the small farmers or small holders and
entrepreneurs to expand investments thereby increasing their
contribution to the economic growth;

WHEREAS, this august Body believes that said request is reasonable,
hence, the same is accorded due course of action;
