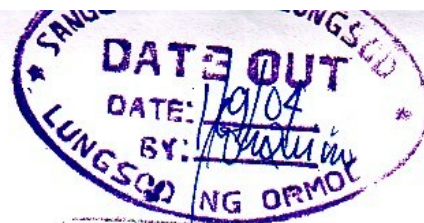
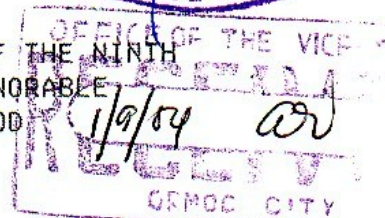

RESOLUTION NO. 2004-002

A RESOLUTION APPROVING ORDINANCE NO. 04 SERIES OF 2003 OF THE BARANGAY COUNCIL OF BARANGAY MACABUG, ENTITLED: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BARANGAY MACABUG WITH A TOTAL AREA 21.57 HECTARES; 2.4 HECTARES AS FISH SANCTUARY AND 19.17 HECTARES AS MARINE RESERVED AREA."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 04, Series of 2003 from the Barangay Council of Barangay Macabug, this city, entitled: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BARANGAY MACABUG WITH A TOTAL AREA 21.57 HECTARES; 2.4 HECTARES AS FISH SANCTUARY AND 19.17 HECTARES AS MARINE RESERVED AREA;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforesaid ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to Review as to whether the said ordinance is consistent with law and city ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Macabug to legislate;


