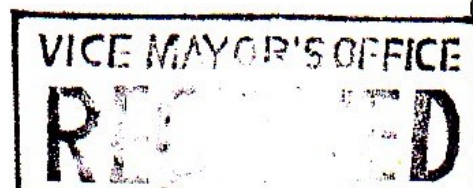
WHEREAS, this Sanggunian is in receipt of a 1st Indorsement dated 08 July 2004 from the Honorable City Mayor Eric C. Codilla re: Letter of Mr. Simon Albino O. Racaza dated 07 July 2004, needing the passage of a resolution requesting the Honorable Court of Appeals for the early resolution of his case;

WHEREAS, on June 21, 2001, Mr. Racaza was issued an appointment as Public Relations Officer IV of the Ormoc Superdome, but was disapproved by the Civil Service Commission Field Office (CSCFO) - Ormoc City on the ground that the same violated CSC Resolution No. 01-0988 dated June 4, 2001 on Midnight Appointments;

WHEREAS, quoted hereunder is the Decision of the Court of Appeals dated 14 August 2003, which states that:

"WHEREFORE, under the premises, the petition for review is GRANTED, the assailed Resolution No. 02-0618 of the agency a quo is SET ASIDE and the appointment of Simon Albino Racaza to the permanent position of PRO IV is declared VALID";

WHEREAS, on September 22, 2003, Mayor Carmelo J. Locsin filed a Motion for Reconsideration and until this date no resolution has been issued by the Court, hence this request;



WHEREFORE, foregoing premises considered on motion of City Councilor Dennis Y. Capuyan, Chairman, Committee on Good Gov't. & Ethics, severally seconded by City Councilors Mariano Y. Corro, Sotero M. Pepito and Jose C. Alfaro, Jr.; be it




