RESOLUTION RESPECTFULLY REQUESTING TAI-PAN DEVELOPMENT, AS OPERATOR OF GAISANO ORMOC, TO INFORM THIS WHETHER OR NOT THE PROVISION OF SANGGUNIAN MEMORANOUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF ORMOC AND TAI-PAN DEVELOPMENT, INC. SPECIFICALLY PAR. XIII, THEREOF, RE: EMPLOYMENT OF ORMOC CITY RESIDENTS, HAS BEEN OBSERVED AND COMPLIED WITH, AND IN CONNECTION THEREWITH, TO FURNISH THIS SANGGUNIAN THE LIST OF THEIR EMPLOYEES WITH THEIR CORRESPONDING PLACE OF DOMICILE, POSTAL ADDRESS IN ORMOC CITY, IF A RESIDENT THEREOF, AND THE NUMBER OF ELECTORAL PRECINCTS WHERE HE OR SHE VOTED, WITHIN THIRTY (30) DAYS FROM RECEIPT OF THIS RESOLUTION.

WHEREAS, TAI-PAN INC. is the operator of GAISANO ORMOC, housed in building which is owned by the City Government of Ormoc;

WHEREAS, for the occupancy of aforementioned building by TAI-PAN, INC., a Memorandum of Agreement was entered into by the City Government of Ormoc and Tai-Pan Development, Inc. on December 8, 1995;

WHEREAS, paragraph XIII of aforesaid Memorandum of Agreement, reads:

"The Operator commits itself to giving priority employment opportunities to Ormoc residents in the operation of the Shopping Mall provided that they are qualified.

WHEREAS, it is alleged by many residents of Ormoc City that quite a number of employees of GAISANO ORMOC occupying ordinary positions are not residents of Ormoc City;

WHEREAS, to verify the truth of the foregoing allegations, it is best to hear the side of TAI-PAN GAISANO DEVELOPMENT, Inc. as operator of GAISANO ORMOC; hence this proposed resolution.

WHEREFORE, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Gregorio A. Yrastorza, Jr., Sotero M. Pepito, Dennis Y. Capuyan & Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION RESPECTFULLY REQUESTING TAI-PAN DEVELOPMENT, INC. AS OPERATOR OF GAISANO ORMOC, TO INFORM THIS SANGGUNIAN WHETHER OR NOT THE PROVISION OF THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF DRMOC AND TAI-PAN DEVELOPMENT, INC. SPECIFICALLY PAR.
