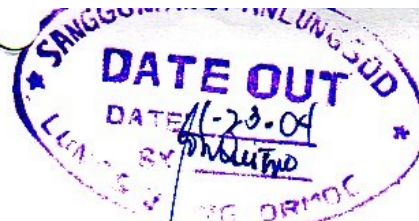

duly seconded by City Councilor Gregorio A. Yrastorza, Jr.; be it


