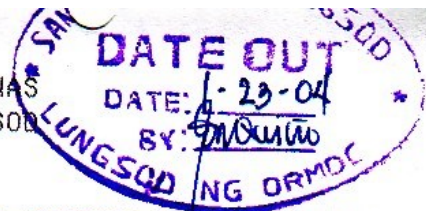
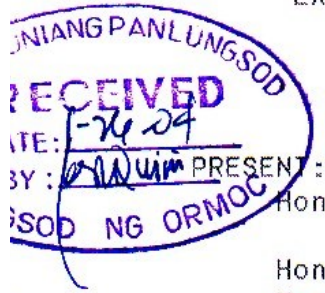

Councilor Ruvinieu E. Mendola; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING

ADOPTED, January 22, 2004.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
