A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO ENTER INTO A RICE LOAN MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY, IN ORDER TO PROVIDE BASIC SOCIAL SERVICES TO THE POPULACE OF ORMOC

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 14 July 2004 from the Office of the City Mayor re: letter of NFA Provincial Manager Jacinto B. Pariña requesting for a resolution relative to the Rice Loan Memorandum of Agreement with the NFA and Ormoc City Local Government Unit;

WHEREAS, said Memorandum of Agreement allows the local government to purchase rice on credit from NFA for relief operation/stockpiling, rehabilitation purposes in calamities/emergencies;
