RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. TO ENTER INTO A MEMORANDUM OF AGREEMENT DEPARTMENT OF ENERGY, REPRESENTED UNDERSECRETARY, ATTY. CYRIL C. DEL CALLAR, AND THE CE LUZON GEOTHERMAL POWER COMPANY, INC., (CE LUZON), AND VISAVAS GEOTHERMAL POWER COMPANY (VGPC), REPRESENTED HEREIN BY ITS PRESIDENT, MR. JOSEPH LEE SULLIVAN.

WHEREAS, this Sanggunian is in receipt of a copy of Memorandum of Agreement among the Department of Energy represented by Undersecretary Atty. Cyril C. Del Callar, the CE Luzon Geothermal Power Company, Inc. (CE Luzon), the Visayas Geothermal Power Company (VGPC) represented by its President, Mr. Joseph Lee Sullivan and the City of Ormoc represented by City Mayor Eric C. Codilla for the Ormoc City Community-Based Livelihood Projects;

WHEREAS, the said Community-Based Livelihood Projects are based on Section 5(i) of Republic Act No. 7638, otherwise known as the Department of Energy Act of 1992 and Section 66 of Republic Act No. 9136 otherwise known as the Electric Power Industry Reform Act of 2001 which states grant financial benefits to the host communities of the energy, generation facility and/or energy resource";

WHEREAS, this august Body believes that said livelihood projects are beneficial to the city, hence, the same be given the necessary course of action;
