WHEREAS, this Sanggunian is in receipt of Resolution No. 43, S. 2004 of the Barangay Council of Barangay Catmon, this city entitled: "A RESOLUTION EARNESTLY REQUESTING AND RESPECTFULLY REQUESTING THRU THE HON.
