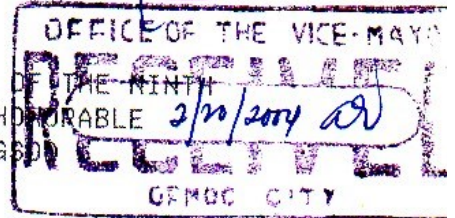

RESOLUTION NO. 2004-017

A RESOLUTION APPROVING ORDINANCE NO. 005-03 OF THE
BARANGAY COUNCIL OF BARANGAY BATUAN, THIS CITY,
ENTITLED: "AN ORDINANCE DECLARING THE COASTAL WATERS OF
BARANGAY BATUAN WITH A TOTAL AREA OF 7.71 HECTARES AS
MARINE RESERVED AREA".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
005-03, from the Barangay Council of Barangay Batuan, this city,
entitled: "AN ORDINANCE DECLARING THE COASTAL WATERS OF BARANGAY BATUAN
WITH A TOTAL AREA OF 7.71 HECTARES AS MARINE RESERVED AREA";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to
Review as to whether the said ordinance is consistent with law and city
