A RESOLUTION RESPECTFULLY REQUESTING THE CITY TREASURER OF ORMOC TO EXERT EFFORTS IN THE COLLECTION OF ALL REAL PROPERTY TAXES DUE THE CITY GOVERNMENT OF ORMOC, AND TO AVAIL OF ALL THE REMEDIES PROVIDED FOR IN THE LOCAL GOVERNMENT CODE OF 1991 IN THE COLLECTION OF DELINQUENT REAL PROPERTY TAXES, AND TO FURNISH THIS SANGGUNIANG A LIST OF ALL DELINQUENT REAL PROPERTY TAXPAYERS, INDICATING THEREIN THE PERIOD AND AMOUNT OF DELINQUENCIES, AND THE EFFORTS EXERTED BY YOUR OFFICE, IF ANY, TO COLLECT THE SAME WITHIN THIRTY DAYS FROM RECEIPT OF THIS RESOLUTION.

WHEREAS, Section 247 of the LGU of 1991 provides that the collection of real property tax shall be the responsibility of the City Treasurer concerned;

WHEREAS, Section 256 of aforementioned LGU provides for the remedies in the collection of real property taxes;

WHEREAS, Section 259 of the same Code, provides for penalty for failure to issue and execute warrant of levy within one year from the time the tax becomes delinquent or within thirty days from the date of the issuance thereof;

WHEREFORE, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Ways and Means, duly seconded by City Councilor Jose C. Alfaro, Jr.; be it


