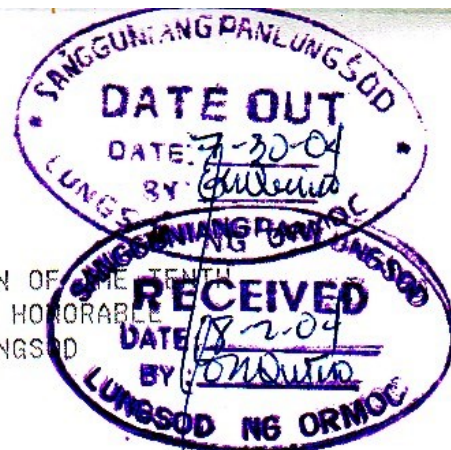

RESOLUTION NO. 2004-022

A RESOLUTION APPROVING ORDINANCE NO. 001 SERIES OF 2004 OF THE BARANGAY COUNCIL OF CAMP DOWNES, THIS CITY, ENTITLED: "AN ORDINANCE AMENDING BARANGAY ORDINANCE NO. 004 SERIES OF 1993, SPECIFICALLY SECTIONS 3 & 7 REQUIRING THE RESIDENTS OF BRGY. CAMP DOWNES, ORMOC CITY, TO PROVIDE THEIR OWN RECEPTACLE FOR GARBAGE AND REFUSE COLLECTION AND TO IMPOSE SANITATION PARTICULARLY ALONG THE SEA SHORE."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 001, Series of 2004 from the Barangay Council of Barangay Camp Downes, entitled: "AN ORDINANCE AMENDING BARANGAY ORDINANCE NO. 004 SERIES OF 1993, SPECIFICALLY SECTIONS 3 & 7 REQUIRING THE RESIDENTS OF BRGY. CAMP DOWNES, ORMOC CITY, TO PROVIDE THEIR OWN RECEPTACLE FOR GARBAGE AND REFUSE COLLECTION AND TO IMPOSE SANITATION PARTICULARLY ALONG THE SEA SHORE;"


