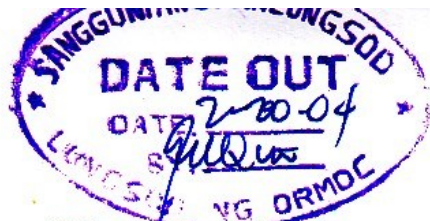
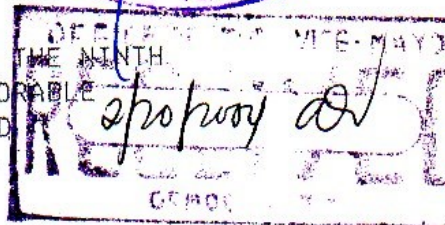

RESOLUTION NO. 2004-022

A RESOLUTION ADOPTING AND CONFIRMING THE GUIDELINES ON THE GRANT OF CASH GIFT TO JOB ORDER EMPLOYEES OF ORMOC CITY FOR CY 2003, PROVIDED HOWEVER, THAT IT SHALL BE CHARGEABLE AGAINST MAINTENANCE AND OTHER OPERATING EXPENSES OF THE OFFICES WHERE THE JOB ORDER WORKER ARE ASSIGNED, AND PROVIDED FURTHER, THAT IT WILL BE RELEASE/GIVEN BEFORE THE PROHIBITED PERIOD FOR THE 2004 ELECTION PERIOD AS MANDATED BY THE COMELEC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 13 February 2004 from the Honorable City Mayor Carmelo J. Locsin re: Guidelines on the Grant of Cash Gift to Job Order Employees of this city for confirmation;
