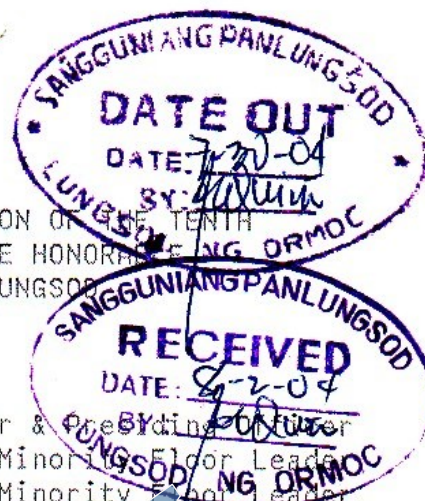

A RESOLUTION REQUESTING THE CITY SURVEYOR TO CONDUCT A RELOCATION SURVEY OF THE LOT OWNED BY THE CITY GOVERNMENT OF ORMOC LOCATED WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY DISTRICT 24, ORMOC CITY, FOR THE PURPOSE OF DETERMINING ITS AREA AND WHETHER THE SAME ARE NOT WITHIN THE JICA FLOOD CONTROL MITIGATION PROJECT AND OR ITS BUFFER ZONE.

ADOPTED, July 29, 2004.


