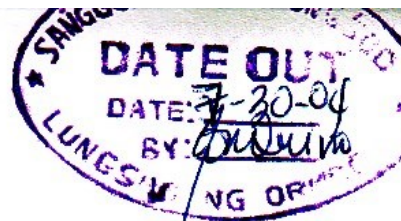
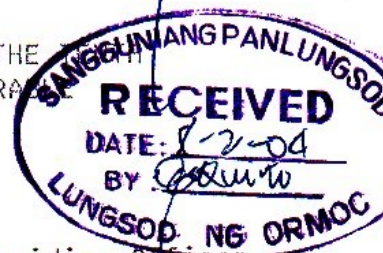

RESOLUTION NO. 2004-025

A RESOLUTION REQUESTING THE ENERGY REGULATORY BOARD TO CONDUCT THE PUBLIC HEARING AND ALL FUTURE PUBLIC HEARINGS IN ORMOC CITY, THE LOCALITY BEING THE CENTER OF LEYECO V OPERATION INSTEAD OF METRO MANILA, REGARDING THE PETITION OF LEYECO V TO GRANT THEM AUTHORITY TO COLLECT FROM THEIR CONSUMERS, BY WAY OF TAX RECOVERY COST WHATEVER TAXES, FEES OR CHARGES THE NATIONAL OR LOCAL GOVERNMENT UNIT WILL COLLECT FROM THEM.

WHEREAS, the Leyte Electric Cooperative V (LEYECO V) is the electric cooperative serving the City of Ormoc and the Municipalities of Albueria, Kananga, Matag-ob, Isabel, Merida, Palompon, Villaba, Calubian, San Isidro, Tabango and Leyte-Leyte;

WHEREAS, LEYECO V being aware of the Supreme Court's decision to allow national and local government units to collect taxes from electric cooperatives, said cooperative has filed a petition for authority for tax recovery with the Energy Regulatory Board;

WHEREAS, anticipating possible collection from concerned LGU's, LEYECO V raised the issue on tax recovery from the consumers with the Energy Regulatory Board, hence, this request;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., duly seconded by City Councilor Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING THE ENERGY REGULATORY BOARD TO CONDUCT THE PUBLIC HEARING AND ALL FUTURE PUBLIC HEARINGS IN ORMOC CITY, THE LOCALITY BEING THE CENTER OF LEYECO V OPERATION INSTEAD OF METRO MANILA, REGARDING THE PETITION OF LEYECO V TO GRANT THEM AUTHORITY TO COLLECT FROM THEIR CONSUMERS, BY WAY OF TAX RECOVERY COST WHATEVER TAXES, FEES OR CHARGES THE NATIONAL OR LOCAL GOVERNMENT UNIT WILL COLLECT FROM THEM;


RESOLVED, FURTHER, to request the other municipalities within the area of operation of LEYECO V to pass similar resolution;
