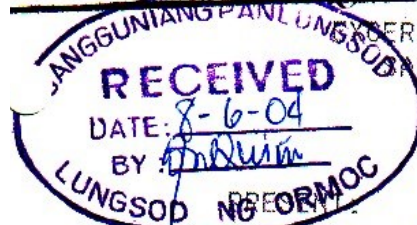

SUPPLEMENTAL BUDGET NO. 02


1. Barangay District III
