RESOLUTION NO. 2004-027

A RESOLUTION ENJOINING THE REGISTER OF DEEDS AND THE CITY ASSESSOR TO COORDINATE WITH THE CITY TREASURER FOR AND EFFECTIVE COLLECTION OF THE TAX DUE ON TRANSFER OF REAL PROPERTIES IN ORMOC CITY.

WHEREAS, our Tax Ordinance No. 93-03, Section 78 imposes a tax on transfer of Real Property equivalent to 3/8 of 1% in the sale, donation, barter, or any other mode of transferring ownership or title of Real Property based on the total consideration involved in the acquisition thereof or of the fair market value in case the monetary consideration involved in the transfer is not substantial, whichever is higher;

WHEREAS, to ensure the collection of the tax referred to in the preceding paragraph, the Register of Deeds before registering any deed transferring ownership or title to real properties, and the City Assessor before cancelling an old tax declaration and issuing a new one in place thereof, brought about by transfer of ownership, should require the presentation of evidence of payment of the transfer tax;

WHEREAS, any transfer of ownership or title of real properties without the corresponding transfer tax having been paid shall be the responsibility of the office which caused the transfer;

WHEREFORE, foregoing premises considered, on motion of Councilor Mariano Y. Corro, Chairman, Committee on Ways and Means, severally seconded by City Councilors Jose C. Alfaro, Jr., Sotero M. Pepito, Claudio P. Larrazabal & Dennis Y. Capuyan; be it
