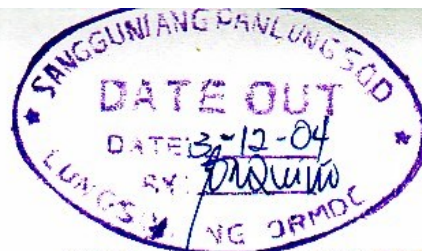
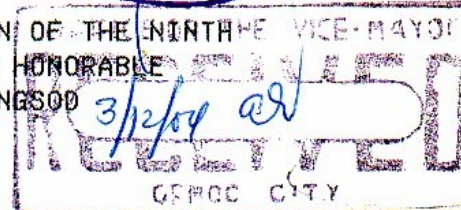

ADOPTED, March 11, 2004.


