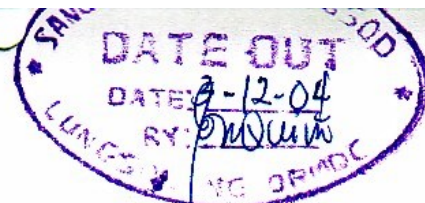
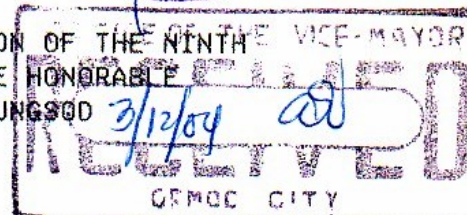

RESOLUTION NO. 2004-028

A RESOLUTION APPROVING ORDINANCE NO. 1-2003 OF THE BARANGAY COUNCIL OF BARANGAY LAO, ENTITLED: "AN ORDINANCE IMPOSING FEES ON BARANGAY CLEARANCE AND BARANGAY PERMITS."

WHEREAS, this Sanggunian is in receipt of Barangay Resolution No. 33-2003 from the Barangay Council of Barangay Lao, this city, embodying Ordinance No. 1-2003 entitled: "AN ORDINANCE IMPOSING FEES ON BARANGAY CLEARANCE AND BARANGAY PERMITS;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether said ordinance is consistent with law and city X X ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Lao to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws & Ordinances, duly seconded by City Councilor Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING ORDINANCE NO. 1-2003 OF THE BARANGAY COUNCIL OF BARANGAY LAO, ENTITLED: "AN ORDINANCE IMPOSING FEES ON BARANGAY CLEARANCE AND BARANGAY PERMITS;"
