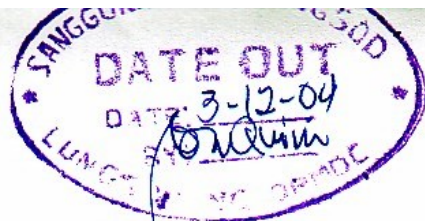
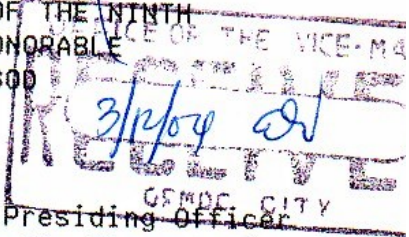

RESOLUTION NO. 2004-029

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, CARMELO J. LOCSIN, TO ENTER INTO A CONTRACT OF ABSOLUTE SALE FOR ROAD LOT NO. 1388G WITH AN AREA OF THIRTY THREE (33) SQUARE METERS OWNED BY MS. AMPARO KANGLEON LOCATED AT BONIFACIO STREET, THIS CITY FOR AS LONG AS THE DISBURSEMENT SHALL NOT VIOLATE THE COMELEC BAN ON THE DISBUSEMENT OF PUBLIC FUNDS.

WHEREAS, this Sanggunian is in receipt of a letter dated 19 February 2004 from the Honorable City Mayor Carmelo J. Locsin, requesting this august Body for the passage of a resolution authorizing him to enter into a contract of Absolute Sale for the road lot, Lot No. 1388G with an area of THIRTY THREE (33) sq. m. owned by MS. AMPARO KANGLEON located at Bonifacio Street, this city;

WHEREAS, the City Appraisal Committee through a resolution dated 02 July 2003 has appraised said property at P3,000.00 per sq. m. and to consider the same as fair, just and reasonable appraised value;

WHEREAS, this august Body believes that said request is valid and reasonable considering that the aforementioned lot, Lot No. 1388G which situated at Bonifacio Street this city is presently utilized as street canal and sidewalk;


