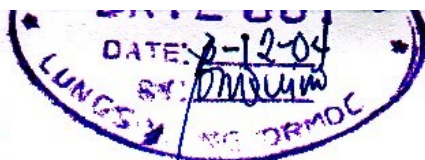
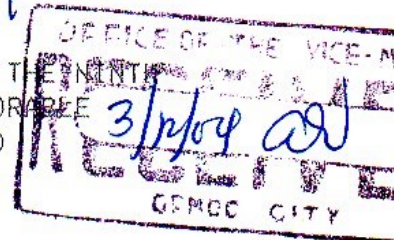

RESOLUTION NO. 2004-030

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST CURRENT APPROPRIATION THE OUTSTANDING ACCOUNT ON ELECTRICITY - STREETS AND ELECTRICITY - PUBLIC BUILDINGS IN THE AMOUNT OF SEVEN HUNDRED SEVENTEEN THOUSAND SEVEN HUNDRED NINETY SEVEN PESOS & 90/100 (P717,797.90).

WHEREAS, this Sanggunian is in receipt of a letter dated 23 February 2004 from Mr. Ildefonso L. Cortes, Jr., OIC - General Services Office requesting this Honorable Body to authorize the City Accountant this city thru a Sangguniang Panlungsod Resolution to charge to current appropriation the outstanding account on Electricity - Streets and Electricity - Public Buildings, this city, in the total amount of SEVEN HUNDRED SEVENTEEN THOUSAND SEVEN HUNDRED NINETY SEVEN PESOS & 90/100 (P717,797.90);

WHEREAS, this august Body believes that said request is valid and reasonable considering that said electric bills were incurred last year hence, the same be accorded due course of action;
