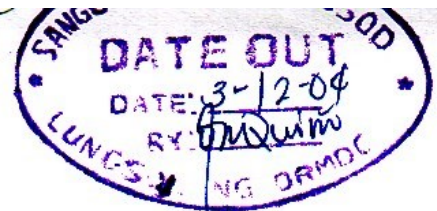
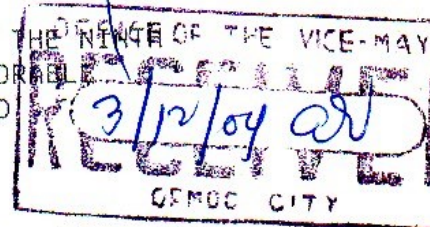

RESOLUTION NO. 2004-031

A RESOLUTION INFORMING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN THAT HIS REQUEST FOR AUTHORITY FOR HIS HONOR TO APPLY, NEGOTIATE, ENTER INTO CONTRACT AND CONCLUDE A LOAN FACILITY FOR AND IN BEHALF OF THE CITY OF ORMOC WITH LANDBANK OF THE PHILIPPINES FOR A LONG TERM LOAN IN THE AMOUNT OF EIGHTY SEVEN MILLION NINE HUNDRED SEVENTY THOUSAND PESOS (P87,970,000.00) FOR THE SOLID WASTE MANAGEMENT PROJECT CANNOT BE GRANTED DUE TO THE NON-SUBMISSION TO THE SANGGUNIANG PANLUNGSOD OF ORMOC THE CITY SOLID WASTE MANAGEMENT PLAN AND ITS ENVIRONMENTAL COMPLIANCE CERTIFICATE (ECC) FROM EMB.

WHEREAS, this Sanggunian is in receipt of a (1st Indorsement dated December 22, 2003 from the Honorable Celso P. Adolfo, City Vice Mayor) letter dated December 18, 2003 and received by the Chairman, Committee on Finance and Appropriation on December 23, 2003, at 3:30 P.M. after the last regular session for CY 2003 had adjourned from the Honorable City Mayor Carmelo J. Locsin requesting for authority for His Honor to apply, negotiate, enter into contract and conclude a loan facility for and in behalf of the City of Ormoc with Landbank of the Philippines for a long term loan in the amount of EIGHTY SEVEN MILLION, NINE HUNDRED SEVENTY THOUSAND PESOS (P87,970,000.00) for the Solid Waste Management Project;

WHEREAS, during the Committee on Finance and Appropriation Meeting on January 16, 2004, with invited persons knowledgeable on the subject matter as resource persons, it was pointed out that the Solid Waste Management Project actually has two (2) components/activities, One (1) for opening up of a new controlled dump site and the second is for a Sanitary Landfill in Brgy. Green Valley, Ormoc City;

WHEREAS, the consensus of the participants in said meeting is that the Sangguniang Panlungsod cannot favorably act on the aforementioned request of the Honorable City Mayor of Ormoc unless he submits to the said Body for approval the City Solid Waste Management Plan to comply with R.A. 9003;

WHEREAS, it was also pointed out that without an Environmental Compliance Certificate from EMB of the DENR, banking institutions will not extend any loan facility for the project;

WHEREAS, to cope up with the present problem of solid waste disposal at Brgy. Macabug, Ormoc City, the advise is for the City Administration to use available equipments of the City Engineer's Office and start developing a one (1) hectare Controlled Dumpsite in Brgy. Green Valley this city, where the City has acquired a property for the development of the Sanitary Landfill;

WHEREFORE, foregoing premises considered, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Finance, duly seconded by City Councilor Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INFORMING THE HONORABLE CITY MAYOR CARMELO J. Parrilla, Jovencio A. Laurente & Fe S. Lladoc. Five (5) Votes Against registered by City Councilors Jose S. Serafica, Eduardo P. Tan, Gregorio A. Yrastorza, Jr., Emeterio Y. Larrazabal, Jr. and Cheryl A. Alfar.
