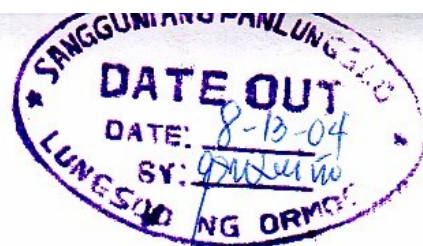

RESOLUTION NO. 2004-034

A RESOLUTION SUPPORTING RESOLUTION NO. 689 DATED JULY 21,
2004 OF THE SANGGUNIANG PANLUNGSOD OF ZAMBOANGA CITY.

WHEREAS, this Sanggunian is in receipt of Resolution No. 689 dated 21 July 2004 of the Sangguniang Panlungsod of Zamboanga City wherein said resolution mentions of the Zamboanga City Shippers Association's protest against the Rules and Regulations Implementing Republic Act 9295, otherwise known as "The Domestic Shipping Development Act of 2004" since it will allow domestic shipping lines to increase their freight, cargo fare and passenger rates up to four (4) times a year or thirty (30%) percent a year thus, putting a burden on products especially coming from Mindanao and will even discourage the small and medium enterprises in Mindanao;

WHEREAS, believing in the stand of the Sangguniang Panlungsod of Zamboanga city in strongly pleading to retain the privileges enjoyed by the said shippers association, the Sangguniang Panlungsod of Ormoc expresses its support for such endeavor;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Transportation and Communication, duly seconded by City Councilor Fe S. Lladoc; be it
