RESOLUTION NO. 2004-035

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. TO ENTER INTO A CONTRACT, ABSOLUTE CONDITIONAL, FOR THE SALE OF LOTS AT BARANGAY SAN ORMOC CITY, THE SITE OF THE ORMOC CITY GOVERNMENT HOUSING PROGRAM TO QUALIFIED RENEFICIARIES/AWARDEES SUPERCEDING RESOLUTION NO. 2002-111.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 29 July 2004 from Mr. Manuel M. Pascual, Secretary to the Mayor requesting the passage of a resolution authorizing the Honorable City Mayor to enter into a contract, absolute or conditional, for the sale of lots at Barangay San Isidro, this city, of the Ormoc City Government Housing Program to qualified beneficiaries/awardees superceding Resolution No. 1002-111;

WHEREAS, it can be recalled that the implementing rules and regulations of the said housing program for the Ormoc City Government employees has been approved through Sangguniang Panlungsod Resolution No. 2001-065 dated 04 October 2001;

WHEREAS, a similar Contract of Sale was previously signed by then City Mayor Carmelo Locsin;

WHEREAS, there is now a need to update said Contract of Sale by allowing the incumbent City Mayor Hon. Eric C. Codilla to sign for and in behalf of the City Government of Ormoc;

WHEREAS, upon review of said contract of sale, it was found out that the same is valid, reasonable and in accordance with existing laws, rules & regulations, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Public Properties, severally seconded by City Councilors Dennis Y. Capuyan, Mariano Y. Corro and Sotero M. Pepito; be it
