A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO A CONTRACT, ABSOLUTE OR CONDITIONAL, FOR THE SALE OF LOTS AT BARANGAY SAN ISIDRO, ORMOC CITY, THE SITE OF THE ORMOC CITY GOVERNMENT HOUSING PROGRAM TO QUALIFIED BENEFICIARIES/AWARDEES SUPERCEDING RESOLUTION NO. 2002-111.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 29 July 2004 from Mr. Manuel M. Pascual, Secretary to the Mayor requesting the passage of a resolution authorizing the Honorable City Mayor to enter into a contract, absolute or conditional, for the sale of lots at Barangay San Isidro, this city, of the Ormoc City Government Housing Program to qualified beneficiaries/awardees superceding Resolution No. 1002-111;

WHEREAS, it can be recalled that the implementing rules and regulations of the said housing program for the Ormoc City Government employees has been approved through Sangguniang Panlungsod Resolution No. 2001-065 dated 04 October 2001;

WHEREAS, a similar Contract of Sale was previously signed by then City Mayor Carmelo Locsin;

WHEREAS, there is now a need to update said Contract of Sale by allowing the incumbent City Mayor Hon. Eric C. Codilla to sign for and in behalf of the City Government of Ormoc;




