## RESOLUTION NO. 2004-037

A RESOLUTION ACCEPTING WITH REGRETS THE RESIGNATION OF HONORABLE DENNIS Y. CAPUYAN AS MEMBER OF THE TENTH SANGSUNIANG PANLUNGSOD OF ORMOC CITY.

WHEREAS, this Sanggunian held its Regular Session on August 12, 2004 at 2:00 o'clock in the afternoon;

during said Regular Session, the Honorable Dennis Capuyan, manifested to the Honorable Members of this august Body, his resignation as Member of the 10th Sangguniang Panlungsod of Ormoc so as to assume his new post as Acting City Administrator effective August 13, 2004;

WHEREAS, Section 82 Par. (a) of Republic Act No. 7160, known as the Local Government Code of 1991, has thus stated:

- "(a) Resignation by elective local officials shall be deemed effective only upon acceptance by the following authorities:

Further, sub-par. (4)(d) of said Article also states that;

"(d) Irrevocable resignations by sanggunian members shall be deemed accepted upon presentation before an open session of the sanggunian concerned and duly entered in its records." X X X X
