

A RESOLUTION APPROVING CITY DEVELOPMENT COUNCIL (CDC)  
RESOLUTION NO. 14 SERIES OF 2004, ENTITLED: "A  
RESOLUTION AMENDING THE PROJECT TITLE OF CONSTRUCTION  
OF ROOFING OF BASKETBALL COURT (P400,000.00 CY 2003  
AIP) AND CONSTRUCTION OF COVERED COURT (P500,000.00 CY  
2003 DAF) BOTH LOCATED AT BRGY. LINAO, TO CONSTRUCTION  
OF COVERED COURT PHASE II AT THE SAME BARANGAY AND  
REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE  
APPROVAL OF THE SAME".

WHEREAS, the 10th Sangguniang Panlungsod ng Ormoc is in receipt of  
1st Indorsement dated 10 August 2004 from the Office of the City Mayor  
Eric C. Codilla, endorsing CDC Res. No. 14 series of 2004, entitled: "A  
RESOLUTION AMENDING THE PROJECT TITLE OF CONSTRUCTION OF ROOFING OF  
BASKETBALL COURT (P400,000.00 CY 2003 AIP) AND CONSTRUCTION OF COVERED  
COURT (P500,000.00 CY 2003 DAF) BOTH LOCATED AT BRGY. LINAO, TO  
CONSTRUCTION OF COVERED COURT PHASE II AT THE SAME BARANGAY AND  
REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE

WHEREAS, Construction of Roofing of Basketball Court (P400,000.00)  
was approved under CDC Resolution No. 5, dated July 22, 2003 while,  
Construction of Covered Court (P500,000.00) was under DAF Projects  
identified by the Office of the City Mayor taken out from 20% Dev't.  
Fund of AIP 2003 dated December 20, 2003;

WHEREAS, Barangay Linao requested for the amendment of title of the  
above projects since it is only in one location and to avoid confusion  
in the implementation of the above project;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructure, jointly seconded by City Councilors Sotero M. Pepito & Mariano Y. Corro; be it
