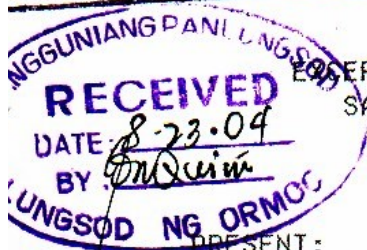
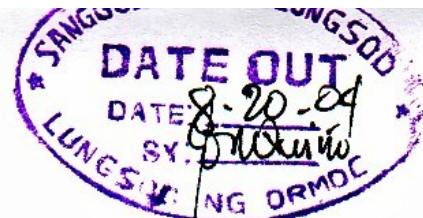

A RESOLUTION APPROVING ORDINANCE NO. 01 SERIES OF 2004 OF THE SANGGUNIANG PAMBARANGAY OF HIBUNAON ENTITLED: "AN ORDINANCE PENALIZING PERSON OR PERSONS MAKING CONNECTION AND TAPPING OF WATER SUPPLY AND PUTTING A METER WHICH IS CALIBRATED BY THE ORWASA, OF THE BARANGAY WITHOUT PRIOR AUTHORITY OR CONSENT FROM THE SANGGUNIANG PAMBARANGAY OF BRGY. HIBUNAON, ORMOC CITY."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 1, Series of 2004, entitled: "AN ORDINANCE PENALIZING PERSON OR PERSONS MAKING CONNECTION AND TAPPING OF WATER SUPPLY AND PUTTING A METER WHICH IS CALIBRATED BY THE ORWASA, OF THE BARANGAY WITHOUT PRIOR AUTHORITY OR CONSENT FROM THE SANGGUNIANG PAMBARANGAY OF BRGY.
