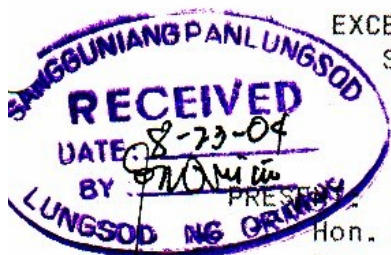

RESOLUTION NO. 2004-046

A RESOLUTION REITERATING THE REQUEST FOR THE REPAIR AND RESTORATION OF THE FUENTE DE LA REINA BRIDGE TO PUT IT BACK TO ITS ORIGINAL BEAUTY AND HISTORIC SIGNIFICANCE.

WHEREAS, the Seventh Sangguniang Panlungsod ng Ormoc passed Resolution No. 95-87 dated 5 October 1995, entitled: "A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR FOR THE REPAIR AND RESTORATION OF BRIDGE FUENTE DE LA REINA TO PUT IT BACK TO ITS ORIGINAL BEAUTY AND HISTORIC SIGNIFICANCE AS A HERITAGE OF THE ORMOCANONS;"

WHEREAS, the FUENTE DE LA REINA Bridge which was constructed sometime in the year 1864, has been recommended to undergo a major repair by Engr. Rosita Cabaña of the City Engineer's Office as mentioned in the aforecited resolution;

WHEREAS, it has been almost ten years since said resolution was passed and this time, said landmark again needs repair and rehabilitation so as to preserve the same and to enhance the cultural and historical background of the City of Ormoc;

WHEREAS, if ever said repair and rehabilitation can be had, it is further requested that an inscription be placed beside the old one, translating into English the Spanish inscription dated sometime in 1864;

WHEREFORE, foregoing premises considered, on motion of City Councilor Manuel T. Fiel, Chairman, Committee on Zoning & Beautification, severally seconded by City Councilors Claudio P. Larrazabal, Jose C. Alfaro, Jr., Fe S. Lladoc, Eduardo P. Tan & Jose S. Serafica; be it


