A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN AND CONFIRM THE REVOCATION OF BONATION EXECUTED BY MRS. GLORIA P. BORROMEO AND ATTY. HORACIO BORROMEO AS DONORS IN FAVOR OF THE CITY GOVERNMENT OF CRMOC AS DONEE, PARCELS OF LAND LOCATED AT BARANGAY BANTIGUE, THIS CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 31 March 2004 from the Honorable City Mayor, copy of Revocation of Donation of Mrs. Gloria P. Borromeo and requesting for the passage of a resolution authorizing him to sign and confirm the revocation of the Deed of Donation executed by Mrs. Gloria P. Borromeo and Atty. Horacio Borromeo as Donors in favor of the City Government of Ormoc as Donee, parcels of land located at Barangay Bantigue, this city;

WHEREAS, said Deed of Revocation of Donation involves parcels of land particularly described as follows:

A parcel of land, Lot 1, Psd-08-010389-D of the subdivision plan, being a portion of Road Lot (LRC) Psd-75440, of the subdivision plan situated in Brgy. Bantigue, Ormoc City, Province of Leyte, bounded on the SE along line 1-2 by lot 1 and 2, of Block 3, (LRC) Psd-75440 of Subdivision Plan; on the W along line 2-3 by Lot 1652, Cad. 256-D; on the NW along line 3-4 by Lot 3, Psd-08-010389-D of the Subdivision plan; and on the NE along line 4-1 by Lot 2, Psd-08-010389-D of the subdivision plan; beginning at the point marked "1" on plan; containing an area of SEVENTY ONE (71) square meters, more or less.

A parcel of land, Lot 2, Psd-08-010389-D of the subdivision plan, being a portion of Road Lot (LRC) Psd-75440, of the subdivision plan situated in Barangay Bantigue, Ormoc City, Province of Leyte, bounded on the SW along line 1-2 by Lot 1, Psd-08-010389-D of the subdivision plan; on the NW along line 2-3 by Lot 3, Psd-08-010389-D of the subdivision plan; and on the SE along line 3-4-1 by Lots 3 & 2, beginning at the point marked "1" on plan; containing an area of SIXTY FOUR (64) square meters, more or less.

WHEREAS, in view of the fact that part of the land donated has not been utilized by the City of Ormoc for Barangay Road, the donor revoked, avoided and cancelled the said donation and demand from the donee, represented by City Mayor Carmelo J. Locsin, this city, the return of the above-described real property but which revocation needs the conformity of the city;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, jointly seconded by City Councilors Eduardo P. Tan and Ruvinieu E. Mendola; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR CARMELD J. LOCSIN TO SIGN AND CONFIRM THE REVOCATION OF DONATION EXECUTED BY MRS. GLORIA P. BORROMED AND ATTY. HORACIO BORROMED AS DONORS IN FAVOR OF THE CITY GOVERNMENT OF ORMOC AS DONEE, PARCELS OF LAND LUCATED AT BARANGAY BANTIGUE, THIS CITY;
