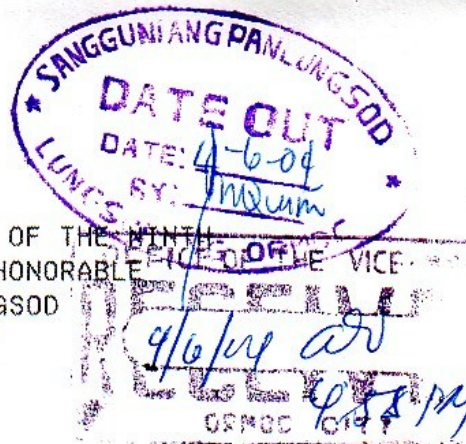

RESOLUTION NO. 2004-048

A RESOLUTION AMENDING SP RESOLUTION NO. 2004-029 DATED MARCH 11, 2004, ENTITLED: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, CARMELO J. LOCSIN, TO ENTER INTO A CONTRACT OF ABSOLUTE SALE FOR ROAD LOT NO. 1388G WITH AN AREA OF THIRTY THREE (33) SQUARE METERS OWNED BY MS. AMPARO KANGLEON LOCATED AT BONIFACIO STREET, THIS CITY, FOR AS LONG AS THE DISBURSEMENT SHALL NOT VIOLATE THE COMELEC BAN ON THE DISBURSEMENT OF PUBLIC FUNDS"; AND TO INCLUDE LOT NO. 1388-I WITH AN AREA OF THIRTY SIX (36) SQUARE METERS LOCATED AT BONIFACIO STREET, THIS CITY, OWNED BY MRS. AMPARO S. KANGLEON.

WHEREAS, this Sanggunian passed Resolution No. 2004-029 dated March 11, 2004, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, CARMELO J. LOCSIN, TO ENTER INTO A CONTRACT OF ABSOLUTE SALE FOR ROAD LOT NO. 1388G WITH AN AREA OF THIRTY THREE (33) SQUARE METERS OWNED BY MS. AMPARO KANGLEON LOCATED AT BONIFACIO STREET, THIS CITY FOR AS LONG AS THE DISBURSEMENT SHALL NOT VIOLATE THE COMELEC BAN ON THE DISBURSEMENT OF PUBLIC FUNDS";

WHEREAS, in a letter dated April 1, 2004, Lot owner Mrs. Amparo S. Kangleon has requested for the inclusion of Lot No. 1388-I with an area of Thirty Six (36) sq. m. in the contract of Absolute Sale for road lot;

WHEREAS, due to inadvertence, Lot No. 1388-I was not included in the contract for Absolute Sale for road lots believing that the same was part of Hermosilla Drive and not part of Bonifacio Street, this city;

WHEREAS, in a Certification issued by the Zoning Administrator, Planning Officer IV, this city, Lot No. 1388-I is located at Bonifacio Street and is classified as City road;

WHEREAS, the City Appraisal Committee through a resolution dated 02 July 2003 has appraised said property at P3,000.00 per sq. m. and to consider the same as fair, just and reasonable appraised value;

WHEREAS, this august Body believes that said request is valid and reasonable considering that said lot has been used as drainage/street canal by the City Government of Ormoc;

WHEREAS, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, duly seconded by City Councilor Fe S. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AMENDING SP RESOLUTION NO. 2004-029 DATED MARCH 11, 2004, ENTITLED: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, CARMELO J.
